

**AMENDMENT
TO
CAMBRIDGE COMMONS SUBDIVISION
DECLARATION OF RIGHTS AND RESTRICTIONS**

This Amendment To Cambridge Commons Subdivision Declaration Of Rights And Restrictions is made by Cambridge Commons Patio Homes, Inc., hereafter referred to as "the homeowners association", with the written approval of more than 66 2/3% of the home owners.

WITNESSETH:

WHEREAS, Pursuant to the Declaration Of Rights And Restrictions dated November 12, 2001, and recorded in Deed Book 7762, Page 978, in the Office of the County Clerk of Jefferson County, Kentucky, the home owners were given the power to amend the Declaration Of Rights And Restrictions, and

WHEREAS, such Amendment must be with the approval of two-thirds (2/3) of the home owners, and

WHEREAS, the aforesaid approval has been made, as evidenced by the attached Exhibit A,

NOW THEREFORE, the homeowners association, for the purposes hereinbefore set forth, pursuant to the provisions set forth in the Declaration Of Rights And Restrictions, recorded as above and in accordance with and by means of the powers therein reserved, and conferring on it, hereby amend the aforementioned Declaration Of Rights And Restrictions as follows:

1. A new section 7.12 of Article VII shall be added which shall read as follows:

"Effective January 1, 2005, no residence may be leased or rented and no residence may be occupied by a tenant, or other person who pays rent to the owner, unless (a) the owner held legal title to the residence prior to January 1, 2005 and the residence was being used for rental purposes on January 1, 2005, (b) the residence is leased to a member of the owner's immediate family (parents, grand-parents, children and grandchildren), (c) the owner or owner's spouse is transferred by his or her employer to a location more than 50 miles from the County Courthouse in Jefferson County, Kentucky, (d) the owner moved to a nursing home or extended care facility, or (e) the owner dies and there is no surviving spouse who resided with the deceased at time of death.

Upon the occurrence of c, d or e above, a residence may be leased or rented for a total period of time not to exceed two (2) years and a lease or rental agreement entered into upon the occurrence of a, b, c, d or e shall be subject to the following restrictions:

i. A fully executed copy of any proposed lease shall be delivered to the Board ten (10) days before the term is to begin; and

ii. Any such lease or rental agreement shall be subject to the Declaration Of Rights And Restrictions, as amended ("the restrictions") for Cambridge Commons Subdivision."

2. Article IV, Section 4.1(b) shall be amended to read as follows:

"b. To inspect, maintain, repair, correct and paint the exterior of Residence Sites, to include, but not limited to, roof maintenance, repair, and replacement; fence maintenance, repair, painting and replacement; shutter maintenance, repair, painting and replacement,

exterior trim maintenance, repair, painting, and replacement, to include painting exterior doors, door trim and window trim as needed for general maintenance, provided however that each homeowner shall be responsible for the cost to repair any damage caused by the negligence of the homeowner or the homeowner's tenants and invitees."

3. Article IV, Section 4.1(f) shall be amended to read as follows:

"f. To take such other action as may from time to time be necessary to maintain the quality and appearance of the exterior of the Residence Sites, in accordance with Article IV, Section 4.1(b), including, but not limited to, the duty to approve the appearance, materials and color of exterior doors, storm doors, storm door glass, any and all screens, security doors, window treatments, security treatments for windows, window glass and exterior lights and other fixtures."

4. Article VII, Section 7.2 shall be amended to read as follows:

"The exterior of each residence shall be maintained by the Owner in an attractive and well-kept manner. No alteration or addition to the front of the exterior structure of a residence shall be permitted, and no alteration or addition to the remainder of the exterior may be made without the prior written consent of the Association."

5. Article VIII, Section 8.2 shall be amended to read as follows:

"Except as permitted in 8.1 of this Article the Board shall not be permitted to borrow money, or incur indebtedness, unless expressly authorized to do so by a majority vote of the lot owners."

6. Article X, shall be amended such that the second sentence thereof shall be deleted and in its stead shall be inserted the following:

"Provided, however, this Declaration or any provision hereof may be modified, altered, amended, or terminated upon a sixty-six and two-thirds percent (66 2/3 %) majority vote of the homeowners in attendance at a duly called meeting at which a quorum is present, provided that not less than five (5) nor more than sixty (60) days prior to the vote a notice is either mailed or hand delivered to each residence specifying the proposed modification, alteration or amendment."

7. Except as set forth herein, the Declaration Of Rights And Restrictions For Cambridge Commons Subdivision and the recorded amendments thereto shall remain in full force and effect.

WHEREAS, the foregoing Amendment to the Declaration Of Rights And Restrictions has been duly passed by an action of the Board of Directors and approved by more than 66 2/3% of the home owners, as shown by the attached Exhibit A, and this Amendment to the Declaration Of Rights And Restrictions shall be in full force and effect upon its recording in the Jefferson County Clerk's Office.
