Article VIII Insurance, is amended to include the following paragraph H:

#### H. Proof of Insurance

On an annual basis, each unit owner shall provide to the Board of Directors, proof of insurance for all coverage's required on the interior of their unit pursuant to this Article VIII.

The Master Deed is amended as set forth above and no further, and is restated and incorporated herein by reference.
