AMENDMENT TO MASTER DEED OF VILLAGE OF WHITE OAKS

The Board of Administration of The Village of White Oaks Association, Inc., hereby gives notice this 20 day of January, 2017, of its adoption of the following Amendment to the Master Deed for Village of White Oaks, recorded in Deed Book 7906, Page 885, in the Office of the County Clerk of Jefferson County, Kentucky, and any subsequent amendments thereto, all of which are collectively referred to herein as the "Master Deed."

WHEREAS, the Board of Administration of The Village of White Oaks Association, Inc., wishes to amend the Master Deed regarding insurance maintained by the unit owners, as set forth more particularly herein, and

WHEREAS, as provided in Section 15 of the original Master Deed, this Amendment was adopted by a vote of at least two thirds (2/3) of the unit owners, who have approved the following Amendment to the Master Deed, and the Master Deed is so amended, as follows:

NOW, THEREFORE, Article 6, Section 6.7, of the Master Deed is hereby amended by adding the following to the end of that section:

Unit owners are required to submit certificates of insurance to the Board or management on an annual basis. The first submission shall be made thirty (30) days after the adoption of this Amendment.

The Master Deed is amended as set forth above and no further, and is restated and incorporated herein by reference.
