AMENDMENT TO THE MASTER DEEDS FOR GASLITE SQUARE CONDOMINIUM HOMES

This Amendment to the Master Deeds for Gaslite Square Condominium Homes is made and adopted as set forth herein by Gaslite Square Condominium Homes, Inc., a Kentucky non-stock, non-profit corporation (the "Association") on the date hereinafter set forth.

WITNESSETH:

WHEREAS, the Co-owners of the Association desire to amend that certain Master Deed Horizontal Property Law of Kentucky For Gaslite Square Condominium Homes, 4875 and 4851 Sherburn Lane, Louisville, Kentucky, of record in Deed Book 4714, Page 68 and that certain Master Deed Horizontal Property Law of Kentucky For Gaslite Square Condominium Homes, Section 3, 4825 Sherburn Lane, Louisville, Kentucky of record in Deed Book 4748, Page 711 and all amendments thereto, in the office of the Clerk of Jefferson County, Kentucky and which are referred to herein collectively as the "Master Deed", and,

WHEREAS, this Amendment is signed and acknowledged by all the members of the Board of Directors of the Association, and the owners of apartments (referred to herein as "units") of the Association constituting at least seventy-five percent (75%) of all owners of the units in the Association; and,

WHEREAS, the Affidavit by an officer of the Association certifying that a copy of this amendment was mailed by certified mail to all mortgagees having bona fide liens of record against any unit not less than ten (10) days prior to the date of such Affidavit pursuant to Section (19) of the Master Deed is attached hereto.

NOW, THEREFORE, the Master Deed is amended as follows and no further:

Section (10) <u>Sale, Leasing, or other Alienation</u> is amended by adding new paragraph (1) as follows:

- (l)(i) Notwithstanding anything in this Section 10 of the Master Deed to the contrary, no unit may be rented or leased for any purpose or duration which includes, but is not limited to, renting or leasing through airbnb or any similar web based service, unless the unit owner held legal title to the unit and the unit was used for rental purposes prior to the recording of this Amendment in the Office of the Clerk of Jefferson County, Kentucky.
- (l)(ii) The terms "rented or leased" refers to any unit not occupied by the unit owner.
- (l)(iii) Any unit owned for the exclusive purpose of being rented as of the date this Amendment is adopted may be used for such purpose until the unit is sold at which time the unit may no longer be rented or leased. Any unit which is not used for renting or leasing as of the date this Amendment is adopted may not be rented or leased at a future date.
- (l)(iv) This Amendment shall not affect occupancy of the unit pursuant to paragraphs (f), (g), (h), and (i) of this Section (10).
